



Some considerations

- We have significantly accelerated implementation of activities since 2022, and will continue to do so in 2023, thanks to the strong support of all parties involved (MPI, SECO, IP managers and developers)
- The budget is very tight, and we had to prioritize
- A project extension to April 2024 was necessary: i) to not lose momentum, ii) to allow a smooth transition between the current project (Phase I) and new one (Phase II) which should start in January 2024.
- This was the result of many efforts by so many people, and the amount of hard work is often not visible.
