INTRODUCTION

- Full name: Vietnam Environment Protection Fund (VEPF).
- Established under Decision No. 82/2002/QD-TTg dated June 26, 2002 of the Prime Minister.
- Operating under Decision No. 2168/QD-BTNMT dated July 5, 2018 of the Minister of Natural Resources and Environment.
- Minimum charter capital of VND 3,000 billion (as stated in Article 158 of Decree No. 08/2022/ND-CP dated January 10, 2022 of the Government).
- VEPF is a non-profit state financial institution under MONRE, operating according to the principles of preserving its charter capital and covering its own management costs.

LOAN INCENTIVE POLICY

Operating under Circular 03/2017/TT-BTNMT dated March 21, 2017 of the Minister of Natural Resources

1. Borrower: Organizations and individuals having investment projects on environmental protection (*as prescribed at Article 55.3 of the Law on Environmental Protection in 2020 and Appendix XXX issued together with the Decree 08/2022/ND-CP dated January 10, 2022*).
2. Loan term: **Up to 10 years**. Grace period: **Up to 2 years**
3. Loan interest rate: **2.6% and 3.6%** (fixed for the loan term).
4. Loan amount for 01 project: Up to **80%** of the total project investment and not exceeding **5%** of the Fund's actual charter capital.
5. Loan amount to 01 project owner: up to **10%** of the Fund's actual charter capital.
6. Loan guarantee: Bank guarantee or mortgage of property.

SOME NEW FIELDS OF TRANSFORMATION AND CONSTRUCTION FOR EIPs ELIGIBLE FOR INCENTIVE LOANS

- Treat and destroy solid waste.
- Recycle or reuse waste.
- Produce products from waste recycling and treatment activities that meet the provisions of the law on product quality (including: Invest in production of recycled plastic, recycled paper, construction materials from waste ash, etc.).
- Produce clean energy; renewable energy (including: Invest in the production of rooftop solar power, waste-to-energy plant; Invest in boilers using biomass energy, etc.).

SUPPORT FOR ENTERPRISES, EIPs

- Assign specialized staff to directly guide and advise on loan procedures and documents (can directly give advice at the unit)
- Organize a 24/7 information reception and processing support line.
- Adopt a quick appraisal and disbursement process aiming to shorten the loan appraisal time.
